THIS NOTICE IS TO INFORM THE CITIZENS OF BRISTOL, TN OF TWO PUBLIC HEARINGS TO BE HELD AT THE COMMUNITY DEVELOPMENT ADVISORY COMMITTEE MEETING ON SEPTEMBER 10, 2019, 5:30 P.M. AT THE EWELL L. EASLEY MUNICIPAL ANNEX CONFERENCE ROOM, 104 EIGHTH STREET. THE PUBLIC HEARINGS WILL PROVIDE THE CITIZENS OF BRISTOL, PUBLIC AGENCIES AND OTHER INVESTED PARTIES AN OPPORTUNITY TO EXPRESS VIEWS REGARDING THE DRAFT CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) AS REQUIRED BY THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT RELATING TO THE CITY'S USE OF COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME INVESTMENT PARTNERSHIP FUNDS DURING THE 2018-19 FISCAL YEAR. THIS REPORT DISCUSSES HOW BRISTOL HAS MET ITS STRATEGIES IN RELATION TO THE CITY'S/NORTHEAST TN/VA HOME CONSORTIUM CONSOLIDATED PLAN.

ESTE INFORME DISCUTE CÓMO BRISTOL HA CUMPLIDO SUS ESTRATEGIAS EN RELACIÓN CON EL PLAN CONSOLIDADO DEL CONSORCIO DE LA CIUDAD / NORESTE TN / VA.

ACTIVITIES ADDRESSED BY THE CDBG PROGRAM MUST MEET AT LEAST ONE NATIONAL OBJECTIVE AS FOLLOWS:

- A. PROVIDE BENEFIT TO LOW AND MODERATE-INCOME FAMILIES
- B. AID IN THE PREVENTION OR ELIMINATION OF SLUM AND BLIGHT
- C. ADDRESS OTHER COMMUNITY DEVELOPMENT NEEDS HAVING A PARTICULAR URGENCY BECAUSE THEY POSE A SERIOUS OR IMMEDIATE THREAT TO THE HEALTH OR WELFARE OF THE COMMUNITY AND WHERE THERE ARE NO OTHER FINANCIAL RESOURCES AVAILABLE

THE HOME INVESTMENT PARTNERSHIP PROGRAM IS AUTHORIZED TO STRENGTHEN PUBLIC/PRIVATE PARTNERSHIPS AND TO EXPAND THE SUPPLY OF DECENT, SAFE, SANITARY AND AFFORDABLE HOUSING FOR VERY LOW-INCOME AND LOW-INCOME FAMILIES.

A DRAFT OF THE ANNUAL REPORT FOR THE GRANTS WILL BE AVAILABLE SEPTEMBER 6, 2019 AT THE BRISTOL PUBLIC LIBRARY, SLATER COMMUNITY CENTER AND DEVELOPMENT SERVICES OFFICE AT THE ADDRESS LISTED BELOW. THE DRAFT CAN ALSO BE VIEWED ON THE COMMUNITY DEVELOPMENT PAGE OF THE CITY'S WEBSITE AT BRISTOLTN.ORG AND FTDD.ORG.

INTERESTED PARTIES MAY COMMENT REGARDING THE DRAFT 2018-19 CAPER REPORT AND PROVIDE INPUT IN PLANNING FOR THE 2020-21 ONE-YEAR ACTION PLAN AND PROVIDE INPUT IN PLANNING FOR THE 2020-2025 FIVE-YEAR CONSOLIDATED PLANS FOR BRISTOL, TN AND THE NORTHEAST TENNESSEE/VIRGINIA HOME CONSORTIUM AT THE PUBLIC HEARING ON SEPTEMBER 10, 2019. THE CAPER HAS A 15-DAY COMMENT PERIOD AND THE ONE-YEAR ACTION PLAN AS WELL AS THE FIVE-YEAR CONSOLIDATED PLAN WILL HAVE 30-DAY COMMENT PERIODS. ALL COMMENT PERIODS WILL BEGIN ON SEPTEMBER 6, 2019 AND END ON THEIR RESPECTIVE DATES.

PUBLIC MEETINGS WILL BE CONDUCTED DURING THE YEAR AND COMMENTS ARE WELCOMED THROUGHOUT THE PLANNING PROCESS.
