Approval of the November 21, 2019 Meeting Minutes

Candace Gump made a motion to accept the November 21, 2019 Minutes as written. Calvin Clifton seconded the motion. Troy took a roll call vote. All in favor. Motion passed unanimously.

FTRPO Coordinator Update

Chase Milner, FTRPO Coordinator

Mr. Milner reported that he has been scheduling one on one meetings with all mayors, highway superintendents, and public works directors throughout the region. He expressed interest meeting with all these said parties this month if they have not already met this spring. Virtual/phone meetings will suffice, or in person meetings OK, practicing safe social distancing.

FTRPO 3Q highlights included:

- FTRPO partners were awarded \$38,300 through the 2019-2020 Traffic Signal Modernization Program (TSMP) (Carter County & Town of Erwin)
- Community Transportation Planning Request reports for the following: Greene County/Greeneville SR-70 from Idletime Drive to Meyers Street, Greene County/Baileyton Van Hill Road, Johnson County Intersection of SR-67 and SR-167, and Mountain City crosswalk at intersection of Murphy Street and Main Street
- Facilitated outreach with Greene County/Baileyton/Private businesses regarding trucking travel center development plans along the I-81 corridor in the Greene County vicinity
- Recruited 1 Rail (Retired CSX employee) and 1 Freight (Old Dominion Freight Line) contacts to join the FTRPO Technical Committee
- Worked with Jonathan Overlay, Executive Director of East TN Clean Fuels Coalition + Tennessee Clean Fuels to prepare a memo that TDOT used for an Alternative Fuel "signage-pending" application submitted to FHWA for I-81 & I-26 on February 26th
- Prepared and submitted the newly awarded Community Transportation Planning Grant (CTPG) application on behalf of the City of Tusculum and Tusculum University for the Tusculum Mobility Plan on January 24th, 2020

I-26 & I-81 Corridor Study Update OCT Region I, Troy Ebbert TDOT

Troy provided a presentation on both the I-26 & I-81 Corridor Studies. I-26 study is in the Task 4 phase. Mr. Ebbert identified I-26 deficiencies and issues, including congestion near I-81 interchange, as well as potential solutions. Bill Albright, MPO mentioned the desperate need for variable ITS message boards and also stated that he has been working with the FTRPO on park & ride surveying. Chris Craig inquired about North Carolina's I-26 status near Asheville (Patton Ave. bottleneck). Troy said he will follow up on the NC update for Mr. Craig.

Mr. Ebbert then provided an overview on the I-81 study, a 20-year, phased set of recommended transportation improvements for the I-40 and I-81 corridors. Purposes for the study include: guidance for decision makers, short and long term objectives identification, and stakeholder corridor promotion. 455 miles of I-40, and 76 miles of I-81 are being studied. Currently, the public comments survey collection period is still going on until mid-June to assess existing & future conditions on traffic flow, safety, alternative fuels infrastructure for freight/transit (and/or lack thereof), and operations & management.

Multimodal Access/Community Trans. Planning Grant Awards - TDOT & RPO Coordinator

Matthew Cushing, TDOT provided an overview of TDOT's Multimodal Access grant, the goal of which is to help fill in the transportation infrastructure gaps in the State Route network. Multimodal grant requires only a 5% match, which can include your engineering expenses \$950K Max request.

- 1. Notice of intent to apply end of July NOI deadline (1-1.5 months period).
- 2. Next round of multimodal applications due likely in late August-September.

Mr. Cushing will be sending out follow-up information in the coming weeks.

CTPG

Chase Milner congratulated the City of Tusculum for the newly awarded Tusculum Mobility Plan, which will help to identify the existing multi-modal, and the future transportation systems as planned by the University Master Plan, including roadways, public transportation, rail, bicycle, and pedestrian facilities that are needed to safely serve the current and anticipated travel demand in the growing population and student body. The Community Mobility Plan process will help to strengthen the connection and community vision between the City's transportation planning and the University's Campus Master Plan, which was last updated May 2002.

Rural Planning Initiative (RuPI) Grant

OCT Staff, FTRPO Coordinator

The Rural Planning Initiative or RuPI Grant program is intended to help rural communities identify needs and promote solutions that lead to an interconnected community with efficient modes of transportation. This initial year 2020 will be a pilot grant to determine if this program will benefit rural communities and to further develop the process.

Eligible communities must lie within the Distressed or At-Risk counties, and be located outside an MPO planning boundary. There is zero local match required.

RPO coordinator outlined the new RuPI grant, applications which will be due back to the RPO Coordinators (cmilner@ftdd.org) by June 10, 2020. Announcements will happen within 10 days of Review Committee decision; July 29, 2020.

The presentation included new TDOT processes for publishing the current and proposed lists on their website the summer prior to the projects. TDOT will communicate with each jurisdiction on the resurfacing list. TDOT will consider changes to be included in the project.

Randy Busler, TDOT's Paving Coordinator provided further input about the 3 year paving list, completed in 2019. He has just submitted the actual FY2021-2023 3 year paving list has just been just submitted to Nashville. Mr. Busler expects new paving list evaluations on projects will be publicly available possibly by late June. Projects will then be in the project design process July/August. Mr. Busler recommended Oct. 1st deadline is a great time to get local information in regarding paving project incorporated requests.
